




- Origin-Destination Survey delayed to 2022 due to the pandemic (requires stable travel patterns for long-range planning)



Engagement to Date


Phase 1: Nov 14, 2019 to Jan 24, 2020 Focused on identifying priority issues that the TMP should address.

Phase 2: Sep 21, 2020 to October 23, 2020 Focused on seeking input on active transportation, new mobility, and the needs of vulnerable residents.








Cycling Facility Growth

Key differences vs. OCP/OPP2013


- Fully integrated within TMP (no separate AT Plan document)
- Project implementation from 2023 to 2046*
- Categories of projects

Infrastructure Projects – require significant construction

Pavement Marking and Signage Projects (cycling only) – implemented largely with pavement markings

Feasibility Study Projects – high degree of risk or unknowns, implementation funding not assured.

*Implementation schedule can be accelerated pending additional AT funding from City/Provincial/Federal sources






Federal Active Transportation Fund

- Includes a \$400M 5yr. fund for infrastructure accessible to Municipalities
- The City will apply part of this funding to accelerate implementation of the AT2023 project list
- Policy component to complement funding






Carling Ave - Parkway North Ramp - Proposed

- A. North/South access to Parkway via North of Carling Ave
- B. Elimination of median to allow for a signalized intersection
- C. Double left turn lanes to Parkway
- D. Double right turn to go West; single left turn to go East
- E. Crosswalk and bidirectional crossride to cross Carling Ave
- F. Multi-use pathways




Carling Ave - Parkway South Ramp - Proposed

- A. North/South access to Parkway via South of Carling
- B. Elimination of median to allow for dedicated turns
- C. Double left turn to go West; single right turn to go East
- D. Multi-use pathways
- E. Crosswalk and bidirectional crossride to cross Carling Ave




Carling Ave - LF Mall Entrance - Proposed

- A. Elimination of merge lanes to be replaced with bike lanes
- B. Dedicated bike lanes and improved pedestrian crossings
- C. Dedicated left and right turn lanes
- D. South bike lane along Connaught Ave




Carling Ave - Croydon Ave - Proposed

- A. Narrowing Croydon and shared use lanes
- B. Dedicated bike lanes and improved pedestrians crossings
- C. Bidirectional bike lanes to connect Norton + Tavistock



Richmond Road - Croydon Ave - Proposed

- A. Improved sidewalks along Croydon
- B. Reduced curb radius at Southwest corner
- C. Two stage turn boxes for bikes
- D. Elimination of on-street parking for a bike lane




Richmond Road - Parkway - Proposed

- A. Unidirectional cycle tracks on either side of Richmond
- B. Raised pedestrian crossing to connect with multi-use path
